Questions were asked regarding a planning application. Highway issues and why no standing member was in attendance at Richard Sewell's funeral. This comment was reiterated by another member of the public who was disappointed not to see a representative there.

A question was raised regarding the time for public participation and borough and county reports included in the same time. It was highlighted that the Parish Council have in the past agreed to keep public participation separate to councillors' reports. The clerk noted the comments.

#### 6) PLANNING

#### a) Applications received

(i) 06/21/0995/D: Approval of reserved matters for pp. 06/18/0315/O - layout, appearance, landscaping, access and scale for residential development of 13 dwellings. Land adj New House Tretts Lane Fleggburgh GREAT YARMOUTH NR29 3AT. A resident had written in with objections with regard to timescales of outline planning approval. Original conditions under item 3 the drawings are not referenced this on this application. The item refers to the number of dwellings, layout, scale and means of access shall be carried out in accordance with the drawings ref:2515.02rev A and 2515.03 rev. It was to be noted that these are not attached to be able to view the drawings. The Tree selection wasn't felt to be suitable for the area the parish council wished to support what was said by tree survey. Consideration of the bedroom numbers and types was noted. To ensure that the provision for local residents to able to have opportunities to buy are not removed. It was commented that the pavement stops abruptly and should be considered to go all the way round the development and not finish at property marked as 3.70 on plans. Proposed S Hacon to SUPPORT the application with the comments as stated. Seconded P Ely. **AGREED**. 1 abstention

(ii) 06/21/0953/F: Proposed two storey rear extension. Tower Lodge Tower Road Fleggburgh GREAT YARMOUTH NR29 3AU. SUPPORT. Proposed S Hacon, seconded P Ely **AGREED** 

(iii) 06/21/0937/F: Proposed replacement of a wire boundary fence with a wood panel and concrete post fence. 7 Westfield Close Fleggburgh Great Yarmouth Norfolk NR29 3DQ. Questions were raised over the application not stating what the height is to be of this new fence. A resident believes that it may be a change of covenant. It was **AGREED** that the clerk gets further details and under the planning policy that a comment will be made via email.

## **12) HIGHWAYS & FOOTPATHS**

12.1 To consider the response from Highways Engineer Justin Le-May concerning issues highlighted within the village. **AP** The Clerk to keep in contact with Justin regarding the updates on the works that Justin Le May has advised will be done.

12.2 To discuss the issues with the footpath that runs by the bowling green. – When crossing the road from the church to the path there is a step that is very muddy. It could pose a danger to a walker if they slipped back into the road. S Hacon suggested attending the area and look at what could be achieved. **AP** S Hacon will take some photos for the clerk to forward to Highways.

## 13) BYGONE WOODS

Following a further visit by Mark Webster from the Conservation Volunteers. Area to look at the potentials of developing part of the woods for the community facility to enjoy. With £20,000 ringfenced to carry out maintenance the conservation volunteers have given a report with costings. It was agreed that this report was a good start but other options/advice from other organisations would be required. The parish council would look to section off the paddock area and the wooded area. The parish council would need to address the current license agreement with the licensee prior to any non-maintenance work commenced and would look at the provision to set up a community trust. The parish council would also look at the options for further funding through donations and grants.

The licensee asked for help with some maintenance. In 2017 it was agreed to help with some maintenance. Subsequently the fencing and posts are failing and require work. It was AGREED for three quotes Proposed K Osborne, Seconded S Hacon. to give assistance and as the land is owned by the PC that it is required to be looked after this includes items that should have been removed by the previous site **AP** Quotes will be sourced for the gates that are in a poor state.
