It was AGREED to respond with OBJECTION, due to Highways access issues and shared access, considerable traffic and to propose 2 on the north side, if residents agree, to reduce traffic. PROPOSED Cllr F Dockerty, seconded Cllr C Merritt.
- 7.1.2. Application 06/22/1075/PAD Application for prior approval for proposed change of use of agricultural building to 2 no. dwelling houses. Jendik Farm Main Road A1064 Fleggburgh NR29 3AE. Deadline 22nd Jan 2023. It was AGREED to respond with OBJECTION due to highlighted mistreatment of wastewater and proximity to Trinity Broads. NOTED that there was no report from highways and the application is opposite a main busy road with narrow access, as well as overdevelopment. PROPOSED Cllr F Dockerty, seconded Cllr C Merritt.
- 7.1.3. BA/2022/0461/LBC Remove window to form opening for french doors. Extension to existing patio. Florence Farm, Marsh Road, Fleggburgh. Deadline 12th Jan 2023. It was AGREED to respond with NO OBJECTION, PROPOSED Cllr Merritt, seconded Cllr Dockerty.
